Handmade Artists/Exhibitor: artist must make the product, includes: gourmet prepackaged goods, paintings, ceramics, photography, etc. Basically if you do not create the items yourself, you will need to come into the event in a different category.

- Wholesale/Imported Exhibitor: exhibitors who sell arts and crafts that are not made by exhibitor, includes: imported jewelry, clothing, food products, beauty products, hats, toys, etc. Includes handmade items not made by the exhibitor.
- Non-Profits: if you apply as a non-profit, you must submit the 501(c)(3) paperwork with application, no exceptions.
- Small Commercial Businesses: businesses that have 3 employees or less. This is specifically for small business not for individual representatives of a larger business.

What we provide you on-site: We provide you with your space only at the Festival. We do not provide tents, tables, chairs, umbrellas, electricity or signage. We do not allow large loud generators

The Vendor hereby indemnifies and holds harmless SOL/2b1/NBPF Inc and EDSF, its agents, associations, employees officers and servants harmless from any and all claims, including costs and attorney's fees resulting from, arising out of Vendor's participation in this event. For the purposes of this agreement, the term "participation" shall include, but not be limited to, the delivery of equipment, merchandise, structures and product to their designated location, the set up and display of any such structure and arts or crafts, and the dismantling and removal of all such items from the area provided by or through SOL/2b1/NBPF Inc and EDSF or its agents, associations, employees, officers and servants.

The Vendor hereby expressly assumes any and all risk of harm or loss arising out of their participation and the participation of other artists in the Festival, including any risk resulting from the particular location of the space designated to them by the Festival Coordinator including any losses of merchandise or damage to their booth.

This agreement shall be effective immediately upon execution and shall continue in effect throughout the event period including set-up and tear-down.
